About ten years ago I had a molehill of an idea that has since turned into a mountain of reality and continues to keep growing and evolving every day. I could not have imagined that raising a few dozen waxworms in my backyard would turn into producing millions of them, and that my original building would quintuple in size and be outgrown. Not once, but twice.. Knowing I needed to expand, I turned to Shannon Benolken at IEDC for assistance. With Shannon's help on my business plan and loan packaging, we worked with Kurt at Woodland Bankto secure a loan. There are not enough words to express my thanks to Shannon and Kurt for all their hard work.

As a result, our new home is a 13,000 square foot series of connected buildings. When all of the plans are put into place, it will turn my backyard venture into one of the largest waxworm producers/suppliers in the United States. It is fulfilling to see a value I have lived my life by coming true: "Start by doing what's necessary; then do what's possible; and suddenly you are doing the impossible."



- Itasca Response Teams Following The Blandin Paper Company's announcement that their #5 unit would be shut down and consequently many workers would be laid off, the Itasca Response Team was formed. IEDC is leading the effort which consists of two teams: The Immediate Business Development and Retention Team, and the Long Term, Future Strategy and Implementation Team. Several initiatives are being considered to provide assistance to the workers and to address the future economic stability of the Itasca County area.
- GRPUC Substation Mark Zimmerman has been assisting the GRPUC and Minnesota Power with a project that would result in a new substation located on property at the former Ainsworth site. The substation would provide the "economic need" required to keep the 115 KVA line intact, support future development at the Ainsworth site and provide backup power for the west and south side of Grand Rapids.
- Connect Itasca Many residents in Itasca County who live in an area covered by the Paul Bunyan expansion project were happy to hear that the long awaited permit from the Forest Service had been approved, allowing Paul Bunyan to lay fiber in the Chippewa National Forest. IEDC worked with Congressman Nolan's office to help obtain the permits.
- Entrepreneur Fund Ian Carlstrom, the business advisor housed at IEDC has taken a job in Fargo and will be leaving early in January. IEDC and the Entrepreneur Fund team will be meeting to discuss next steps.
